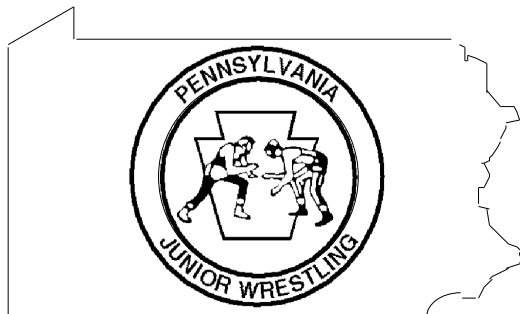

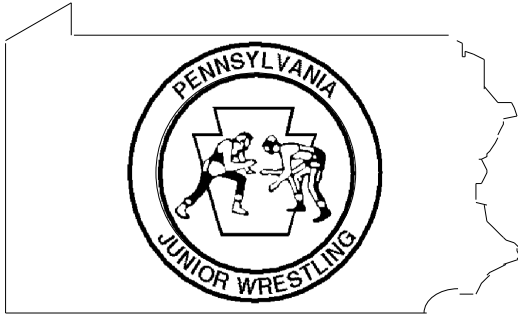

PJW RULES

- 1) Wrestler must reside in one of the following counties; Adams, Cumberland, Franklin, Perry, York.
- 2) Wrestler may only submit 1 Entry.
- 3) Wrestlers in grade 7, 8, and 9 with PIAA defined Junior High eligibility may participate.
- 4) No wrestler with PIAA defined Varsity or Jr. Varsity experience will be permitted.
- 5) An 11 and 12 year old on a Jr. High roster may choose only 1 PJW tournament series (Youth or Jr. High).
- 6) Refer to <http://www.piaa.org/schools/eligibility/default.aspx> for PIAA defined eligibility.
- 7) No school issued uniforms or singlets are permitted.
- 8) No weight changes permitted after 5:00 pm on Friday, February 13, 2015.
- 9) No satellite weigh ins or early weigh ins
- 10) Wrestlers not making weight at weigh in will forfeit their entry without refund.
- 11) Birth Certificate and proof of residency of both wrestlers must be provided if challenged.
- 12) Advancing wrestlers must complete advancement process prior to leaving the tournament.
- 13) Advancing wrestlers will be required to pay a refundable \$75.00 deposit for singlet use prior to leaving tournament.
- 14) Advancing wrestlers must provide a copy of Birth Certificate prior to leaving tournament.
- 15) All Bout times are 1:30 – 1:30 – 1:30. PIAA Overtime rules will apply.
- 16) Head gear is required, shoe laces must be secured, PIAA hair rule applies, and mouth guard is required to cover braces.
- 17) Seeding will be by records provided on entry form.
- 18) Full double elimination format with wrestle back for true second.
- 19) Application must be completed in its entirety.
- 20) **Release and Waiver of Liability Agreement & Participant Code of Conduct form must be completed and brought along to weigh in.**
- 21) Failure to comply with any PJW or PIAA rule will result in disciplinary action and/or forfeiture of participation.

RELEASE AND WAIVER OF LIABILITY AGREEMENT & PARTICIPANT CODE OF CONDUCT

I am voluntarily participating with knowledge of the danger involved, and agree to assume any and all risks of bodily injury, or death, whether those risks are known or unknown. As consideration for being permitted by PJW, and any owner, administrator, tournament director, chairperson of the premises holding any of the events, to participate in these activities and use the premises and facilities, I forever release PJW or any Lessor or any PJW affiliated organization, and their respective directors, officers, employees, volunteers, agents, contractors, and representatives (collectively "Releasees") from any and all actions, claims, or demands that I, my assignees, heirs, distributees, guardians, next of kin, spouse and legal representatives now have, or may have in the future, for injury, death, or property damage, related to (i) my participation in these activities, (ii) the negligence or other acts, whether directly connected to these activities or not, and however caused, by any Releasee, or (iii) the condition of the premises where these activities occur, whether or not I am then participating in the activities.
